Cooling-off period: Students are able to change their mind and cancel their intended training. A cooling off period of 3 business days applies from the the date they complete and sign their enrolment documentation.

Certificate 3 Guarantee: Given the benefits that accrue to individuals from training, students undertaking Certificate III training and non-concessional students undertaking lower level training, will be required to contribute to the costs of their training through a co-contribution fee.

Under the free training for Year 12 graduates initiative, the Queensland Government will cover the full cost of training in a high priority qualification. This means eligible participants will not be required to contribute to the cost of their training. Please be aware that if your course is being funded by the Queensland Government under the Certificate 3 Guarantee program you are only eligible for one government subsidised training place under this funded program. <u>User Choice</u>: The government contributes towards the total cost of training for apprentices and trainees. Other contributions by industry, employers, apprentices and trainees will generally be required.

Not all apprenticeships and traineeships attract government funding. The funding priority will determine the level of public funds contributed to training regardless of whether the qualification is an apprenticeship or traineeship. The Certificate III in Blinds, Awnings, Security Screens and Grilles is a priority two course.
